For the Tweed, a new dam on Byrrill Creek will have better land use outcomes as opposed to raising the Clarrie Hall Dam. The latter will further inundate prime agricultural land. The other options listed above will complement the overall strategy.

1. Decentralised desalination, 2. Regional desalination, 3. Raise Clarrie Hall Dam level, 4. Planning for climate change impacts on coastal groundwater resources. Please comment on why you think these options are least important? :

It has been shown that desalination is not cost effective especially when the Northern Rivers Region usually has up to a metre of rain annually that currently now mainly flows out to sea. Forever the climate has continued to change; in the 1970s there was a general warning of an expected ice age! With limited resources, there are more important issues to be addressed.

The part statement on the Byrrill Creek option "The proposed inundation area is an area of high biodiversity and is home to a number of threatened flora and fauna species" is moot. When this site was purchased it was

degraded agricultural land consisting primarily of lantana and tobacco bush. The biodiversity change is a direct result of the Council establishing a hardwood species plantation for a short term financial gain.
